GARBAGE PICKUP

RESIDENTIAL: CUSTOMERS INSIDE THE CITY LIMITS - \$4.00 CHARGE PER MONTH. CONTAINERS ARE ASSIGNED TO YOUR ADDRESS IN CASE DAMAGED OR STOLEN- EACH HAS A RECORD SERIAL NUMBER

ALL GARBAGE MUST BE IN THE CONTAINERS PROVIDED BY THE TOWN OR IT WILL NOT BE PICKED UP NO LIQUIDS, STONES, MASONRY PRODUCTS, HAZARDOUS CHEMICALS OR MEDICAL WASTE NO DEAD ANIMALS.....

COMMERCIAL PICKUP

THE TOWN WILL FURNISH 1 CONTAINER PER BUSINESS. ADDITIONAL CONTAINERS MAY BE PURCHASED FROM THE TOWN.

ONCE A WEEK ON FRIDAYS \$20.00 FOR 1-3 CONTAINERS-TWICE A WEEK -TUESDAY AND FRIDAY \$30.00 FOR 1-3 CONTAINERS

ADDITIONAL COST OF \$5.00 PER MONTH FOR EACH CONTAINER OVER 3....

LARGE ITEM PICKUP

NO BUILDING MATERIALS OF ANY KIND-FRAMING, LUMBER, PLYWOOD, SHEETROCK, DECKING, CONCRETE, ROCKS, BRICKS, OR SIMILAR MATERIALS. RENTAL PROPERTY <u>WILL NOT</u> BE CLEANED OUT AND PLACED AT THE ROAD FOR PICKUP WHEN PROPERTY IS VACATED-THIS ALSO APPLIES TO THE LANDLORD AS WELL....

BRUSH PICKUP

MONDAY, TUESDAY, WEDNESDAY AS TIME ALLOWS

INSIDE THE CITY LIMITS ONLY- BRUSH MUST BE IN A NEAT PILE WITH CUT ENDS TOWARD THE ROAD AT THE CURBSIDE. BRUSH OR TREES CUT BY PAID CONTRACTORS MUST BE DISPOSED OF BY THE CONTRACTORS TRIMMING OR BY THE OWNER
