Customer Statement for the Control of Cross-Connection

Cross connection is any physical arrangement whereby a public water supply is connected, directly or indirectly, with any other water supply system, sewer, drain conduit, pool, storage reservoir, plumbing fixture, or other waste or liquid of unknown or unsafe quality which may be capable of impairing contamination of the public water supply as a result of backflow. Bypass arrangement, jumper connections, removable sections, swivel or change over devices through which, or because of which, backflow could occur are considered to be cross connections.
