FOR THE CONSIDERATION OF EVERYONE ATTENDING WE ASK THAT YOU NOT TEAR DOWN YOUR BOOTH UNTIL THE FESTIVAL IS OVER. THIS CAN HURT OUR CROWD AND BOOTHS AROUND YOU. COST FOR ONE 10 x 10 SPACE IS \$25.
